# END-USER LICENSE AGREEMENT FOR DYNACOM® SOFTWARE

### IMPORTANT - READ CAREFULLY

This End-User License Agreement is a legal AGREEMENT between you (either as a registered individual user or as the registered user/representative and on behalf of a single entity) and Dynamic Flow Computers for the use of Dynacom® software, which includes computer software and may include associated media, printed materials, and/or electronic documentation ("Dynacom"). By installing, copying, or otherwise using Dynacom, you agree to be bound by the terms of this agreement. If you do not agree to the terms of this agreement, then DO NOT install or use the Dynacom® software.

#### DYNACOM® SOFTWARE LICENSE

- 1) GRANT OF LICENSE: The Dynacom® software is licensed; not sold. This agreement grants you, the Dynacom® user, the following rights:
  - Dynacom<sup>®</sup> is available for use with any Dynamic Flow Computers product at no cost. End users may install and use one copy of Dynacom<sup>®</sup> per flow computer. Users agree to indemnify, defend and hold harmless Dynamic Flow Computers against any claims arising out of any allegation that use of Dynacom<sup>®</sup> violates any such laws.
  - STORAGE/NETWORK USE. You may also store or install a copy of Dynacom® on a storage device such as a network server, used only to install or run the software on other computers over an internal network. In the event more copies are required, verbal agreement must exist to dedicate a distinct license for each developer using Dynacom® from the storage device. Any given license for Dynacom® may not be shared or used concurrently or otherwise on different computers or by different developers in a given organization.

## 2) OTHER RIGHTS AND LIMITATIONS

- Users of Dynacom® software may not modify, reverse engineer, decompile, or disassemble Dynacom®, except and only to the extent that such activity is expressly permitted by applicable law. Dynacom® is licensed as a single product. Its component parts may not be separated for use on more than one computer.
